

## INSTRUCTIONS TO BIDDERS

Sealed envelopes containing bids must be addressed to the Licking Township Board of Trustees, c/o Andrea Lynch, Fiscal Officer, 8332 Licking Trails Road, Thornville, Ohio 43076, and have the name of the bidder and “AVONDALE ROADS OPW PROJECT” printed on the outside.

- **Sealed bids are due by 4:00 p.m., June 14, 2024.**
- Sealed bid opening will take place at the Licking Township Board of Trustees Regular Meeting to be held on Monday, 6/17/24 at 7:30 p.m. @ Licking Township Fire Station #600 located at 9384 Jacksontown Road, Jacksontown, OH 43030.
- All material shall meet the requirements set forth in the specifications section of this package
- An Exemption Certificate available upon request.
- All prices must be firm. Bids must be prepared in ink or typewritten. Bids must be signed in ink. No bid will be accepted if it is not signed and dated in the space provided.
- Unit prices shall be entered, extended, and totaled on all items. Total price for the road must be added and the sum entered as the Grand Total Bid.
- Each bid must be accompanied by a Bid Guaranty Bond for the full amount of the bid, a certified check, cashier’s check or a letter of credit equal to 10% of the bid amount. If the successful bidder has submitted a check or a letter of credit, a bond must be filed for the full amount of the bid upon entering the contract.

The Licking Township Board of Trustees reserves the right to accept or reject any or all bids and to waive technicality. The Licking Township Board of Trustees reserves the right and may let the work as a whole or in convenient sections, as it determines, pursuant to O.R.C. 5575.02. **If the Licking Township Board of Trustees chooses not to resurface all of the roads bid, the bidder must disclose the financial impact of such choice.** The Licking Township Board of Trustees reserves the right to non-perform any specific project.

## **SPECIFICATIONS**

### **DESCRIPTION:**

See attached Project Scope/Estimate sheet

### **COMPOSITION:**

Aggregate size and proportions shall be similar to those specified in the O.D.O.T. Construction and Materials Specifications Handbook. Maximum aggregate size #8.

Bitumen content shall be within the following limits (Percent of Total Mix), 4.0-12.0.

**PLEASE NOTE (if applicable):**

- 448 T-1 ASPHALT OVERLAY = LIMESTONE AGGREGATE MIX
- Resurface with Item 441 Asphalt Concrete Surface Course, Type 1, (448), PG64-22, LS
- Item 617 Compacted Aggregate Shoulders (avg 1' width by 1.5" depth)

### **TACK COAT:**

Pavement shall be treated with a tack coat before paving. Tack coat should meet O.D.O.T. specifications and shall be placed at a rate of 0.05 gal./sq.yd.

### **MOTORPAVE (COLD MIX PAVING):**

As per O.D.O.T. specifications.

**ACCEPTANCE OF ANY OR ALL MATERIALS IS SUBJECT TO THE ON SITE INSPECTION OF THE LICKING COUNTY ENGINEER OR HIS REPRESENTATIVE.**

### **TRAFFIC CONTROL:**

Successful bidder shall maintain one lane of traffic at all times and will be required to provide flaggers to perform traffic control measures that are necessary for the project.

**STARTING DATE:**

Starting date for this project is 7/10/24 (REQUIRED BY TOWNSHIP)

**COMPLETION DATE:**

Completion date for all roads shall be 10/30/24 (REQUIRED BY TOWNSHIP)

**FAILURE TO COMPLETE ON TIME:**

The following schedule of liquidated damages shall apply to this contract:
